1.4. OBITUARIES

Mr Ton Marteijn – † 20 March 2021

Ton Marteijn served the korfball community for about half a century, starting in the late 1940s as chairman of his local korfball club, and retiring in 1997 as Secretary General of the International Korfball Federation.

Over many years, Marteijn was a referee at the elite level in the Netherlands and internationally, following which he started as a referee teacher. He conducted courses all over the globe, with an emphasis on the United States and in Asia, including the very first referee course in India in 1985 and in Chinese Taipei in 1986. Over many years, together with korfball's coaching education icon Adrie "Swan" Zwaanswijk, he led the international korfball Summer course at Papendal in the Netherlands.

In parallel, Ton Marteijn started a career as a sports administrator, including Chairman of the Zeeland Korfball Association, Chairman of the KNKV South-West District, President of the Zeeland Sports Council, Exco Member of the Royal Dutch Korfball Association KNKV, and Exco Member of the Netherlands Sports Federation (predecessor of the current NOC*NSF). From 1984 until 1997, Ton Marteijn was Secretary General of the International Korfball Federation. Together with then-President Bob de Die, Ton Marteijn was instrumental in getting korfball included in the program of The World Games in 1984 and in obtaining recognition by the International Olympic Committee in 1993. He was awarded the honorary membership of the IKF in 1997.

The international korfball community will remember Ton Marteijn as an extremely committed developer of the sport of korfball across the globe, with a very clear and often uncompromising view on the direction the development of our sport would need to take. Korfball globally would be different if it were not for the many contributions that Ton Marteijn has made.

Received the IKF Badge of Honour, for having served for many years as chair of the IKF Medical Committee and IKF Therapeutic Exemptions Committee.

Mr Walter Eijsink (NED)

Received the IKF Badge of Honour, for his extensive service as International Referee, and subsequently as member of the IKF Referees committee and as Referee educator and assessor.

Mr Piotr Urbanski (POL)

The IKF Executive Committee has awarded the IKF Pin of Merit to Mr Piotr Urbanski, for his extensive contribution to the development of korfball over a very long period of time.

Mr Urbanski was one of the first korfball players in Poland since 1987. In 1993, he took on the Presidency of the Polish Student Korfball Association, then a member association in the IKF, and developed this to encompass clubs for youth and adults across Poland, to finally convert this into the Polish Korfball Federation in 2012. In 2017, the Polish Korfball Federation became a member of the Polish Olympic Committee, receiving full recognition as a World Games sport. Mr Piotr Urbanski lead the Polish Federation throughout this extensive period of time, driving the development of youth and competitions, and also obtaining extensive support for the Polish national korfball team. In 2019, Mr Urbanski stepped down from his position.

2. COUNCIL REPORT

The year 2021 still has been defined by the coronavirus pandemic, which continued to force us to readjust our yearly planning and also had a negative effect on the operations of all our Member Organisations, with almost all national organisations throughout the world being forced to constantly adjust their activities.

IKF has continued to adapt and to focus in online contents and initiatives, as a complement to the few activities that could be organised on-spot. Work meetings have taken place online year round within IKF structures and also between IKF and member countries and other sports associations. Also development activities took place, from several IKF Committees and also from our national organisations, like webinars, online courses and other online events.

Our focus was the recovery of competitions and development after the pandemic, both internationally but also nationally with our korfball organisations, korfball clubs and schools.

During the year 2021, the Executive Committee has had monthly online meetings, except in July and August, and met in September, in Utrecht, and the Council had a meeting in October, in Antwerp.

With respect to Anti-Doping, 2021 was still determined by the WADA Code Compliance process. The Anti-Doping Rules and procedures as well as several forms were updated according to new WADA Code and the new International Standards.

The ADAMS system was used not only for whereabouts requirements but also for missions and third party agreements. With the organisation of some international competitions, it was possible to increase testing, but still it was severely affected by the pandemic due to the decrease of both international and national competitions.

We continued to ensure that the IKF and all of our national organisations have in place WADA compliant antidoping rules, together with approved testing plans and suitable anti-doping education programmes so that we can remain compliant as a sport within the WADA code.

At the IKF Office, Geke Maat, (IKF Administrative and Project Officer), Tilbert La Haye (CEO) and Erik Buizer (Financial Administrator) continued their work as in previous years.

Competition

During the first months of the year multiple tournaments still had to be postponed or cancelled, this despite of all the efforts from the IKF Competition Committee and host countries in alignment with the IKF Office. The IKF CEO was involved in many of the evaluation and update meetings that took place with the host countries and subscribed teams. All to assure a clear and transparent decision making process and limiting



the financial risks of all stakeholders involved. Luckily in the last part of the year it was finally possible to organise a total of three events. The U21 Korfball World Cup (KWC) and the IKF European Korfball Championship A and B division were held in the months of September and October. To make it possible to host the events, the IKF Office has taken the lead in preparing Covid-19 Event Protocols and Covid-19 Event Rules. This to ensure that for all host countries, participating teams and (IKF) officials the requirements for the events were clear and everyone could participate safely.

During the last months of the year the preparations towards The World Games 2022 in Birmingham (USA) have become more intense. The IKF Office takes care of the communication to the participating teams and IKF Officials, modifying the information that comes in from the Birmingham Organising Committee and the International World Games Association. Also, in alignment with multiple involved IKF committees preparation regarding the venue, competitions, communication, marketing, livestreaming, etc. are taken place.

IKF Congress and General Meeting

During the IKF European Korfball Championship Division-A the IKF also organised the first ever hybrid IKF Congress and IKF General Meeting in Belgium. Organisationally this was a challenging event in an already busy period of time, with the three korfball events taking place in the same timeframe. With the help of the KBKB for the operational part of the event and the IKF EXCO regarding the content of the congress, the event was a great success. Many countries that in the past were not able to attend, could now do so online. Increasing the involvement and engagement of all the IKF member countries enormously. The survey that was send out after the event amongst all participants also showed nice feedback. Both the organisation as the content of the event were evaluated very positive.

IKF Team managers Input Portal (TIP)

Following the preparational work in 2020, the new TIP portal has been put in use for the 2021 IKF events. Following the experiences with the portal during the year some extra adjustments had to made to make it fully working. In the beginning of the year, before start using the TIP, the complete database of players has been cleaned so that only valid players profiles can be selected.

Erasmus+ Sport Grant

The IKF was awarded a Grant by the European Commission for the duration of 12 months. The partners of the project were SWISS Korfball, Polish Korfball Association, Federation Korfbal France, All-Ukrainian Korfball Federation, Slovak Korfball Association and the Welsh Korfball Association. The Erasmus+ project helped the National Federations to strengthen their organisation. During multiple (mostly online) sessions, they followed a step-by-step method to identify their main goals, challenges and opportunities, as well as ideas



to address those. This has led to a development- and action plan to increase korfball participation in their korfball communities. The partners have involved the local clubs in this process so that those can assist in the practical implementation of the plans. Furthermore, all partners organised youth korfball activities, to kick-off the practical implementation of their plans.

A new project proposal and grant application for 2022 was written and submitted to the European Commission in the spring of 2021. Unfortunately the project was not granted to the IKF at the end. The project was positively evaluated by the EU, passing the threshold score with great ease. However, due to the high number of applications from organisations from all over Europe, at the end the score was not high enough to be allocated with a grant.

IKF thanks all volunteers who contributed to the running of the IKF and the development of korfball, especially in these difficult pandemic times. The progress that the IKF has made would not have been reached without this valuable contribution in time, creativity and energy.

In addition to time, we received assistance from many individuals and organisations, among which we particularly mention the Royal Dutch Korfball Federation (KNKV) and Royal Belgian Korfball Federation (KBKB), the International Olympic Committee (IOC), the Association of IOC Recognized International Sports Federations (ARISF), GAISF, the Swan Fund and our main sponsor MIKASA. We hope that we may keep counting on the support of all these individuals and organisations in the years to come.

5.1. Strengths:

- 5.1.1.Structures for korfball management exists on the Continent.
- 5.1.2.Able bodied committed and dedicated volunteers are available to manage korfball and korfball expansion on the Continent, although on a limited scale.
- 5.1.3.Support from the IKF, IKF DEC, SWAN Fund and KNKV for development and expansion activities on the Continent

5.2. Weaknesses:

- 5.2.1.Communication from the affiliated countries is very poor and, in some instances, nonexistent.
- 5.2.2.Distances within Countries has a severe influence on the strength of the competitions and the potential for competitions within all of the countries
- 5.2.3.Standard of play, coaching and refereeing in the different countries
- 5.2.4.Standard of administration of the Federations
- 5.2.5.Knowledge and experience of the volunteers within the Federations
- 5.2.6.Support from Governments is limited to very few sports and the difficulties experienced by Federations to access government support and finances.



5.2.7. No full time continental administration to support the executive

6. **OPPORTUNITIES AND RISKS IN THE CONTINENT**

6.1. **Opportunities:**

6.1.1.Lot of potential countries still not accessed on the Continent

6.2. **Risks:**

- 6.2.1. Political instabilities and safety issues within Countries
- 6.2.2. Socio-economic situation on the Continent
- 6.2.3. Infrastructure on the continent is very limited
- 6.2.4. Sport is a very low priority for Governments as well as the people and communities on the Continent given the other desperate needs

7. ANY OTHER COMMENTS REGARDING THE CONTINENT

- 7.1. Countries are now returning to normal or a sort of normal which is advantage to the sport as now gathering are allowed .
- 7.2. Due to non-korfball activity in other countries for a longer period there is need to rekindle it through official visitation and communication with the federations and supreme sport bodies to make sure the games are active
- 7.3. Little support to countries that are going to atake part in the IKF AAKC 2022 and or the hosting country looking at the current state of economy due to COVID 19
- 7.4. To start thinking of establishing IKF Africa offices and at least 1 or 2 important officers and volunteers.

3.2. IKF AMERICAS



1. DEVELOPMENT AND EDUCATION OF EXISTING MEMBERS IN THE CONTINENT

It was a challenging season for all America's countries considering the impacts faced by Covid Pandemic which left no other choice for some of our friends but to suspend their entire activities.

Fortunately, we were able to keep the connection with Korfball community in America, strengthening the bonds between players and representatives from different countries, using social media to share training sessions, historical moments of previous tournaments and keep the desire to return to the courts, schools and bring Americas back to the international competitive scene.

ARGENTINA:

- The country which was one of the first to recover korfball activities promoted many clinics, face-to-face and virtual ones. Clinics and Coach courses happened in Florencio Varela, Brandsen, Buenos Aires, San Miguel, Beriso and other places;
- The Asociación de Korfball Argentina (AKA) invited Ivan Aquino, coach from National Team of Hong Kong, to promote a 4-episodes of virtual clinics of Korfball;
- First Beach Korfball Tournament in Parque Sarmiento;
- Regional Tournament in Rosario, with exhibitions events to invite people to participate;
- Florencio Varela, the city that hosted one of the first international tournaments in America in 2014, received the 5 best teams in Argentina to compete in a season-ending tournament;
- Argentina was also able to produce Korfs in order to facilitate the distribution of materials in Argentina. AKA delivered korfs among Clubs, Schools and government sports representatives.

BRAZIL:

- Friendly Tournament at Casimiro de Abreu (RJ). This event took place in NOV/2021 and was the only face-to-face meeting held by Federação do Estado do Rio de Janeiro (FCERJ) to the



current teams practicing Korfball in Brazil. In this episode, we observed around 60 participants, between seniors and sub-15 players.

 Promoting content through social media. Many corfebol representatives (Clubs and teachers) promoted live streaming sessions to talk about Korfball, presenting its dynamics, debating rules in order to keep in touch with friends and their supporters.

COLOMBIA:

- Korfball4 Tournament; organized two times by Korfball Federation Colombia (KFC) with support from the Silver Arrows members from Cali.
- Coach Course at Buga City, with the objective to create a new Korfball training center.

COSTA RICA:

- Very restricted by Covid Pandemic, our friends from Costa Rica were capable of offering online Korfball instructions to 5 (five) PE teachers and worked on an action plan to resume activities in 2022.

DOMINICAN REPUBLIC:

- In Barahona, FEKORD offered korfball clinics and exhibitions for participants from many different ages. This event was very well received, with great possibilities for us to create a new team in Paraíso. The event finished with an invitational tournament with teams from Barahona and Santo Domingo.
- Korfball Clinics in Fundación Cabral and Polo, other cities with representatives who expressed interest in learning about korfball after the events held in Barahona.

SURINAME:

- Due to the distance between representatives from Suriname Federation, players and the country, we have no opportunity to promote Korfball activities in Suriname by 2021.

PERU:

- Although our friends from Peru became official members this year, Asociación Peruana de Korfball (APK) organized a virtual tournament for the dissemination of korfball, involving students of different ages to assimilate its rules, strengthening the international community of korfball.



2. PROSPECTIVE MEMBERS IN THE CONTINENT

Interest in IKF membership has been shown from the side of Uruguay.

Already for a couple of years there is a small but stable korfbal community in Uruguay. They had the aim to create an official federation and further develop korfball from there. Unfortunately the corona crisis has put on hold this ambition. It is unclear how they will come out of this.

3. PLANS IN THE CONTINENT FOR COMPETITIONS FOR 2022

For the year of 2022 it is planned to take place the Pan-American Championship (PAKC).

4. MARKETING IN THE CONTINENT

The visibility of korfball within the continent is made via the IKF Americas Social Media Committee and the social media channels: Facebook, Instagram and Twitter.

5. STRENGTHS AND WEAKNESSES IN THE CONTINENT

5.1 Strengths: Especially the Latin countries are very passionate about korfball and participating in international events. Federations are quite independent and very creative in developing korfball. Also, the National Federations within Latin America like to connect with each other.

5.2 Weaknesses: Most of the countries in the Americas are E-countries and therefore sustainability is a challenge. Resources within the continent are limited and in general little governmental support and assistance from sponsors is there. Also, a lot of support/knowledge (and therefore resources) from outside the continent is necessary to be able to organise IKF.



6. OPPORTUNITIES AND RISKS IN THE CONTINENT

6.1 **Opportunities:** Most of the countries are very active and like to invest in development and grow, both nationally and internationally. They are easily activated for new initiatives.

6.2 **Risks:** Because of limited organisational strength and small financial budget sustainability of many of the National Federations is a challenge.

3.3. IKF ASIA



1. DEVELOPMENT AND EDUCATION OF EXISTING MEMBERS IN THE CONTINENT

- 1.1 Due to the strict restriction measures caused by the COVID-19 pandemic, unfortunately, the scheduled IKF Asia Korfball Championship in Seoul (Korea) and IKF U23 World Korfball Championship in Taipei (Chinese Taipei) had been cancelled and all on-site international communication activities were ceased in 2021.
- 1.2 However, the number of online domestic activities and international communications increased much beyond expectation. The pandemic might be like a blessing in disguise to teach us realizing the online communication can be the economically efficient alternative to encourage IKF Asia in cooperation with its members more closely and frequently.
- 1.3 Malaysia Korfball Association innovatively organized the IKF Level I Coach Course in December, demonstrating to the world what a notable alternative tool of coaching education was by utilizing the remote & hybrid learning format with IKF instructors.
- 1.4 The on-site activities like national championships, training sessions, coach and referee education programs, or general meeting etc., were restarted in almost all A, B, C and D countries since 3rd quarter year.
- 1.5 In general, more countries learned taking advantage of online software to maintain or revive the korfball development as more as possible to compensate the frustrating situations out of control resulting from pandemic.
- 1.6 IKF World Korfball Award for Innovation was awarded to Hong Kong China Korfball Association in the hybrid IKF General Meeting in Antwerp, Belgium for their long-term tireless efforts in leveraging associations with famous consumer brands, TV and movie personalities to create extensive publicity about korfball and help the association to evolve over many years.



2. PROSPECTIVE MEMBERS IN THE CONTINENT

- 2.1 We continue to prioritize the development and growth of the existing member countries in Asia, however, IKF Asia has been closely cooperating with Korfball Association of Thailand to introduce korfball into Cambodia and Vietnam.
- 2.2 An active korfball club exists in Brunei and had ever built a squad visiting Malaysia to play korfball games and have mixed training with players of Malaysia. Malaysia Korfball Association will maintain the close communicating with our korfball friends in Brunei and hopefully an official korfball organizing body of Brunei would submit the application for being an IKF member in the near future.

3. PLANS IN THE CONTINENT FOR COMPETITIONS FOR 2022

- 3.1 11th IKF Asia-Oceania Korfball Championship is planned to take place in November in Taipei, Chinese Taipei.
- 3.2 IKF Beach Korfball World Cup (Asia) is scheduled in December in Thailand.

4. MARKETING IN THE CONTINENT

- 4.1 The managers of IKF official media were very enthusiastic in collecting and sharing various interesting information of korfball activities in many countries of Asia.
- 4.2 Some national korfball association well utilize the strength of celebrities to make korfball visible tremendously. Hong Kong China Korfball Association cooperated with 1 female and 1 male famous pop song singers to record a theme song for the association. Chinese Taipei Korfball Association continued to give training and officiating supports for the korfball match played between Team Blue and So Red comprising of all celebrities in the Reality Show, "All Star Sports Day", broadcasted during the prime time 8 to 10 o'clock in the evening of Saturday and Sunday and also uploaded afterward on YouTube channel reaching over 1.2 million views.
- 4.3 Many countries proactively took the opportunities to promote korfball on the multi-sport exhibition occasions like National Sports Day/Week.



4.4 Malaysia ingeniously incorporates korfball value with the major social desirability by using the motto "To build a Sustainable Malaysia through The Korfball Way", which has been highly appreciated by the public and Malaysia Sports Commissioner Office (KBS).

5. STRENGTHS AND WEAKNESSES IN THE CONTINENT

5.1 Strength:

- 5.1.1 The post holders of IKF Asia were competent and enthusiastic having fluent communication and close cooperation with the IKF Council.
- 5.1.2 Neighbours like to support neighbours. Chinese Taipei, China, Hong Kong China, and Thailand are enthusiastic to provide education supports and share informative knowledge to other Asian countries.
- 5.1.3 Most of the Asian countries are ambitious to play the international tournaments because their governments, NOCs, and media value the accomplishments of the IKF and IKF Asia official tournaments.
- 5.1.4 The school and university systems of most countries are beneficial to the development of korfball in various aspects including PE class, student club, and varsity team with regular training sessions every week.

5.2 Weaknesses:

- 5.2.1 Some countries have not regularly organized their local korfball competitions.
- 5.2.2 Only Chinese Taipei and China were able to reach the top 12 of IKF WKC and the playing level of the other Asian countries lagging behind is significant.

6. OPPORTUNITIES AND RISKS IN THE CONTINENT

6.1 Opportunities:

6.1.1 Southeast Asian Games is a promisingly feature multi-sport event for korfball being included in the competition program. Cambodia. There have been 5 IKF members, Indonesia, Philippines, Malaysia, Singapore, and Thailand in the name list of 11 countries. Korfball has



existed in Brunei for many years and other targeted new korfball countries would be Vietnam and Cambodia.

6.1.2 Both 2-korf and 1-korf Korfball4 games have been recognized by prospective and advanced countries as the optimal platforms to trigger the engagement and participation of the youth population before they eventually transit to korfball8.

6.2 Risks:

- 6.2.1 More and more other sports artificially design new games played with males and females together, which may grab some youth population from korfball context.
- 6.2.2 Most of the National Sport Ministries in Asia over-emphasize the development Olympic sports and Asian Games sports in comparison of their support on the World Games sports.
- 6.2.3 Other team sports' enthusiasm in attracting the youth population by instituting small-sided games in various fields urban, street, beach, etc.

7. ANY OTHER COMMENTS REGARDING THE CONTINENT

- 7.1 Strategic developments towards 2020 2023 and contributions to IKF objectives
- 7.2 Fostering the korfball development of countries in a more structural way by helping them fulfil the goals of key projects in their signed IOC Pledges.
- 7.3 Increase the investment of the development and education on the countries in Southeast Asia including the current members (Indonesia, Malaysia, Philippines, Singapore, Thailand) and promising new members like Cambodia, Vietnam, and Brunei in order that korfball can be included in the competition program of Southeast Asian Games (SEA Games).
- 7.4 Convincing that the IKF Asia and IKF Asia-Oceania competition affairs will be operated in a very structural way.
- 7.5 Fostering high-order competition officials from various countries
- 7.6 Cultivating coordination officers, chairs of jury, and referee assessors from higher ranked and middle countries.
- 7.7 Increasing the population of high-standard IKF referees from all countries.
- 7.8 To encourage IKF official friendly international matches.



7.9 Maintaining the investment of development and education on the D, E, & F countries.

- 7.10 To securing sustainability of countries at the bottom of the table
- 7.11 To strengthen management, grow number of players, and increase national competitions in middle ranked countries to make next step.
- 7.12 Providing experts and knowledge for the professionalization of higher ranked countries to make next step (including elite performance). To strengthen management, grow number of players, and increase national competitions in middle ranked countries to make next step.
- 7.12.1 Providing experts and knowledge for the professionalization of higher ranked countries to make next step (including elite performance).

3.4. IKF EUROPE



The European Continental Confederation is still being restructured.

There is only one active working group inside IKF Europe, the European Competitions Working Group.

In 2021 was created the IKF Europe Taskforce, with the aim of launching the IKF Europe Continental Federation in 2023.

- 1. DEVELOPMENT AND EDUCATION OF EXISTING MEMBERS IN THE CONTINENT
- 1.1 2021 was also a year where several challenges happened due to covid, especially for the development of korfball within Europe. Only a few korfball activities were able to take place and mainly at the third quarter of the year. In general the overall number of activities has been very low.
- 1.2 International events had to be cancelled until September 2021, and only the IKF U21 European Korfball championship and the IKF European Korfball Championships division A and B took place

2. PROSPECTIVE MEMBERS IN THE CONTINENT

2.1 At this moment there are no countries known that are practising korfball, or are interested in developing korfball, outside of the current IKF member countries.

3. PLANS IN THE CONTINENT FOR COMPETITIONS FOR 2022

- 3.1 For 2022 there are two European seniors events on the IKF Competition Calendar. The IKF WKC Qualifiers.
- 3.2 Next to the two seniors events there is also an U19 World Korfball Championship planned for April and an IKF U21 European Korfball Championship on the calendar for September 2022.



3.3 In 2022, it will be launched the new club competition, the IKF Korfball Champions League. A new format that will bring together the previous IKF Europa Cup and IKF Europa Shield. This new competition will be launched in September 2022, with several rounds to be played during the season.

4. MARKETING IN THE CONTINENT

4.1 The marketing of the continent, compared with the other continents, is doing relatively well. However, this mainly due to the fact that the IKF headquarters and Social Media department are located in Europe and have easy access to all information that is there.

5. STRENGTHS AND WEAKNESSES IN THE CONTINENT

- 5.1 **Strength:** With Belgium and The Netherlands, plus all B-countries present, there is a lot of korfball knowhow available within the continent. Also, the travel distances within Europe are relatively small. This makes participation in international events, as well as friendly matches between countries, well accessible for most of the countries. Finally, the strong economic status of most European countries, especially compared with many countries in the other continents, makes it easier for countries to find budget for different type of initiatives and projects.
- 5.2 Weaknesses: Although the relationship between the National Federations is good and multiple projects between individual countries have taken place and still are taken place, there is no structural collaboration between the National Federations within Europe as a whole to achieve common goals. Initiatives to re-establish the European Continental Confederation have not been successful over the last years. Also, there is a significant group of young and vulnerable National Federations that are not yet able to (completely) look after themselves.

6 OPPORTUNITIES AND RISKS IN THE CONTINENT

6.1 **Opportunities:** Within the European Union there are multiple possibilities to present projects to apply for European Sports subsidies. Such projects demand fruitful collaboration between National Federations and apart from the content of the project itself, bring in extra budget for the



involved partners. The re-establishment of the European Continental Confederation could stimulate the development of common European goals and an action plan to accomplish those goals.

6.2 **Risks:** There are multiple weak National Federations within Europe. Without extra attention from the IKF and/or countries within the continent, it is expected that those countries in the coming years will get lost for korfball.

3.3.1. IKF EUROPE TASKFORCE

After many years of inactivity IKF Europe found a next breath. In 2021 various discussions with key member countries resulted in the appointment of an IKF Europe Taskforce by the IKF Council at the end of the year.

Five pioneer European federations drafted a mission statement to go forward with the continental federation, develop mutual initiatives, streamline communication and prepare the federation for formal board elections in 2023.

The appointed taskforce members :

- Iwona Zak (chair)
- Yves Daelmans (Vice chair & marketing)
- Ellen Pearce (communication)
- Jan-Sjouke Van den Bos (development & education)
- Remco Winter (competitions)
- Björn Elewaut (referees)
- Jochen Schittowski (governance)



The taskforce will contact all European member federations and propose actions and projects put forward by these member federations in line with the drafted mission statement.

Ultimate goal will be to persuade all European federations to participate and contribute to the continental federation in order to support our mutual and separate objectives to grow and strengthen korfball.



3.5. IKF OCEANIA



1. DEVELOPMENT AND EDUCATION OF EXISTING MEMBERS IN THE CONTINENT

- 1.1 New Zealand's korfball development continues to benefit from its school and youth programme which has now run for several years. In 2021 this programme, run in the Canterbury Region, continued as the focus of ongoing, sustained growth for korfball, bringing in youth age players, their teachers, and parents, to significantly enlarge and strengthen the local korfball community. Of course, Nationwide lockdowns continued to present some problems, mainly the ability to develop other regions
- 1.2 Highlights from the programme during 2021 included:
- 1.3 The continued employment of two regional development officers.
- 1.4 Successful events run throughout the year with up to 40 teams participating.
- 1.5 New Zealand continues to promote its international squads u17, u19 & u21 with a hope to return to competition as soon as possible, no travel was permitted in 2021
- 1.6 A successful Korfball league was held in Christchurch.
- 1.7 Korfball in Australia struggled in 2021 with many International visitors returning home, Sydney became dormant and Melbourne suffered one of the World's longest lockdowns, the 2021 National Championships had to be cancelled one week prior to the event taking place and efforts to move it to later in 2021 were stopped by covid restrictions. South Australia was not as restricted and managed to run a full year of outdoor, indoor and beach korfball, just without visitors from interstate.
- 1.8 South Australia managed to run a full version of its State League competition for 20 weeks and increased the number of teams from 2020.
- 1.9 There was limited youth development in South Australia in 2021, besides club level, as there were restrictions on the capacity of external parties to enter schools.



2. PROSPECTIVE MEMBERS IN THE CONTINENT/REGION

2.1 In Oceania our current plan continues to be the strengthening of our existing members Australia and New Zealand, resources and distance are major barriers to developing prospective members in our region given we are not a continent joined together but rather a collective of islands.

3. PLANS IN THE CONTINENT FOR COMPETITIONS FOR 2022

- 3.1 With lifting of most internal border restrictions occurring at the completion of 2021 Korfball Australia will be looking at running it National Championships in June in Victoria. This will be in addition to the usual ongoing leagues
- 3.2 New Zealand will continue with their ongoing leagues primarily focussed in Christchurch
- 3.3 Korfball Oceania will start building their plans towards regular Oceania events in light of commitment to IKF to have Oceania Championships running from 2024

4. MARKETING IN THE CONTINENT

4.1 Marketing in both Australia and New Zealand continues to be largely via Social Media due to the financial constraints in both countries. New Zealand continue to provide great content and late in 2021 a number of South Australian clubs picked up their social media presence that resulted in World Korfball picking up some of their posts.

5. STRENGTHS AND WEAKNESSES IN THE CONTINENT

These are an ongoing theme, largely repeated year after year until either one or both countries can break the cycle experienced by minority sports

5.1 Strength:

- Strong sporting culture (strength and weakness)
- Community approach to sport given limited size
- Volunteer network in major korfball centres (SA & Canterbury)

- INTERNATIONAL KORFBALL FEDERATION
- Increased youth participation for strong school presence in New Zealand.

5.2 Weaknesses:

- Travel restrictions placed on both countries specifically about returning travellers has made it financially impossible to travel internationally until our borders are opened up without the requirement to islolate. Further, as airlines return to both countries there are less flights at higher cost so this will be a factor possibly well into 2023.
- Minor sport logistics access to venues, media, promotion, funding are everyday problems.
- Distance from korfball opportunities will continue to be a weakness in Oceania, when added to the lack of funding, these creates financial difficulties to ensure regular competition is maintained. The distance is not confined to International but rather distance between our two countries, distance between the regions within our countries and of course distance to the rest of the korfball world – enhanced by current border restrictions hopefully to be lifted 2nd half of 2022.
- Inability to attract volunteers in less represented regions where Korfball has been active previously, Auckland, Wellington, Sydney, Queensland
- Government recognition due to size
- costs of shipping korfball specific equipment creates a financial barrier.

6. OPPORTUNITIES AND RISKS IN THE CONTINENT

- 6.1 **Opportunities:** In New Zealand the opportunities exist to continue to make significant impact in the school system ultimately increasing participation and recognition of the sport. 2021 continued this trend despite covid. The opportunities to expand the NZ program to Auckland and other regions is now realistic given the changing dynamic of the pandemic. The other opportunity that exists is creation of more Oceania events. These have been ad hoc up until this time with 2017 being the last event but hopefully with border restrictions being removed we can build a sustained program.
- 6.2 **Risks:** The immediate RISK with growth and the desired international participation that comes with it, is funding and volunteers. As previously stated, the risk that our status as a genuine sport are continually challenged by sports such as Netball, Basketball, Football (various codes) and so we need to find avenues to firstly attract players to the sport but then maintain their interest.



The best way to do that is via international participation which then is a financial risk as the cost to participate becomes too high as highlighted above. With growth comes a significant risk in the lack of volunteers to run the sport and the development, this is an issue Australia has faced for a long time. New Zealand have experienced a wave of volunteers and enthusiasm that comes with International participation, the key is maintaining that enthusiasm.

7. ANY OTHER COMMENTS REGARDING THE CONTINENT

7.1 7.1 With the continued success of the youth program in New Zealand there has been maintained communication between our two countries and whilst still restricted by distance and the covid restrictions in place for the first part of 2022, there is a greater appetite for regional development. We appreciate that this has taken a long time and has had many false starts so the hope is that it continues and the region works together, potentially with Asia, to strengthen our position Internationally. Both countries recognise the importance of Victoria (Melbourne) initially and hopefully Sydney in the future as being better International gateways (compared to South Australia) to allow for more cost effective competitions. Both countries remain committed to growth and improved international participation at youth and senior levels.

4.1. APPEALS COMMITTEE

In 2021 no cases were brought before the IKF Appeals Committee. The committee did not convene in 2021.

4.2. ATHLETES COMMITTEE

It was great to see korfball competitions from domestic to international starting again over the course of the last year. One such tournament (the A-Division European Korfball Championships) allowed the athletes committee to attend the IKF Congress & GM in person to see first-hand what happens "behinds the scenes" in order to get a better appreciation of what organisational effort takes places including some of the decision making process. This also gave rise to the opportunity to network with other committees which led to the "Official in the Spotlight" article through the marketing/digital committee. This was all in the hope of getting the athletes committee name/contact further out into the korfball domain. What we have learnt from the above is that essentially there needs to be a bit of a shake-up; as such through this next reporting period we will be looking at the following:

- Having representation of the Athlete's Committee at the ExCo level.
- Proposing a structural change to the athletes Committee in order to get better engagement
- and involvement from athletes.
- Exploring any digital platforms where athletes can connect with us via an app based system.

Together with that we will also be seeking views on various "korfball 4" formats in order to gauge interest in the concept as a whole, but also the various forms of the game that exist (e.g. beach, urban etc.).

4.3. BEACH KORFBALL COMMITTEE

1. Meetings

Due to the worldwide restrictions due to the corona measures, there was only the possibility to have 1 physical meeting. This took place during the IKF congress in Antwerp on Thursday 28 October 2021. Beside this, regular consultations took place between the committee members by e-mail or online meeting (Teams



In addition, many conversations were held with the organizers and those responsible of beach korfball (events) around the world on the other, to support in the organization of beach korfball at a local level. This happened by mail or online meeting.

2. Tasks

The main task of the Beach Korfball Committee in 2021 was the preparation of the "IKF World Beach Korfball Championship 2021" in Morocco.

In addition, the committee also has the following responsibilities:

- Advising the EXCO on policy development by preparing policy- and strategic plans
- Promoting the development of beachkorfbal
- Evaluating beach korfball rules and provide the Playing Rules Committee with advice regarding this matter
- Coordination and evaluation of the international beach korfball events

3. IKF World Beach Korfball Championship 2021

The IKF Beach Korfball World Cup (Europe) was planned on the 30th and 31st of July 2021 in Nador, Morocco. Due to the consequences of the Corona pandemic, this event was first postponed to the 10th and 11th of September. Unfortunately, it was not yet possible at that time to take place, after which the organisation was postponed to the summer of 2022.

4. Future

After the postponement of the IKF World Beach Korfball Championship in 2021, this event will take place on the 19 and 20 August 2022. Due to the very good preparations for the event in 2021, this was again awarded to the Moroccan Korfball Federation for the organisation in Nador.

Stimulating all continents to organize beach korfball activities, promoting beach korfball and beach korfball knowledge sharing are the core tasks for the years to come.

4.4. COACHING AND EDUCATION COMMITTEE

Jorge Alves, Chairperson

Meetings

A CEC online General meeting was held on 25th July 2021

The focus was:



- The criteria to become an IKF Coach Instructor, to be used on the Open calls for Coach Instructor;
- The publishing of the IKF Coach Course Level I & II handbooks.

During the year there were some bilateral online meetings on these topics.

Overview

As part of the Erasmus+ 2020 project, it was published the IKF Coach Course Level I & II handbooks for IKF instructors and participants. The contents including the instruction videos on the IKF YouTube channel were made available to all national federations to be used for their own national courses or seminars in spite of, conducting an official IKF Coach Course it is still necessary to be an official IKF instructor.

In continuation of the IKF Level I and Level II Coaching courses, the KNKV was awarded an Erasmus+ grant for 2021 and started working under the guidance of Ben Crum, on an e-book for advanced korfball coaches to be published in 2022.

Coach Courses

In August it was held in Gárdony (Hungary) the first IKF Coach Course Level II used the new contents and handbooks. The IKF instructor was Ivo Kracik (CZE) and there were 37 attendants.

In October it was held an IKF Coach Course Level I by Kevin Robson (FRA) in Saint-Étienne (France) for 10 attendants.

In December, due to the COVID19 restrictions, the Malaysia Korfball Association organised the first IKF Coach Course Level I totally online. With the use of several cameras, TV screen, and sound system and the help of 4 instructor assistants, the IKF instructors Inglish Huang (TPE) and Jorge Alves (POR) conducted for 3 days this course, opening the doors to future use of online sessions in conducting IKF Courses.

During the IKF Congress in November, it was presented by the chair of DEC Jorge Alves the new Platform -Korfball Academy. It is the intention of CEC that in the near future all coach education will be done through this platform.

The main matters that have come to the table of the IKF CC are:

- The only tournaments in 2021 were the U21 KWC and the IKF EKC's A and B.
- The Asian Competition Working group organised Teams meetings with the IKF CC chair and the CEO to align the Asian events.
- Fixed items on the agenda will be matters raised by the continental working groups, ECWG and ACWG. Africa and the Americas do not have a Competition Working Group and are directly represented by the IKF CC. Extra information is gained through the CEO and DEC/Swan Fund.
- Sam Stevenson chaired the ECWG and Jeroen Breeschoten was active as the new member.
- Marc Breugelmans joined meetings with the CEO and ICT specialists to further enhance the implementation of long lists, final lists and team sheets. This have led to the Tournament Import Portal (TIP). The player's database was revised and cleared of wrong and double names.
- The CEO, Tilbert La Haye and Administrative and Project Officer, Geke Maat, actively joined the meetings for the feedback that has been received from bidders and organisers.
- The office and the IKF CC received reports of the tournaments from the CO's and the jury chairs. It was decided to have these reports as a regular item of the meetings.
- The IKF CC has adapted rules and regulations with respect to new playing rules. Especially the change in the golden goal rule needed special attention.
- After many discussions about a new format of both IKF ECup R1, IKF ECup final round and IKF EShield the executive committee proposed a new pilot that would be called IKF Europe Korfball Champions League with four rounds in total.



 The IKF CC gave guidance to the exco concerning the number of nations that would participate in the IKF WKC 2023 and the respective qualification criteria. The decision of the council to proceed with 24 participants was noted by the IKF CC that will start with the development of different playing schedules based on agreed criteria with respect to chances to become world champion, maximal number of playing days, maximal number of playing days for each participant and rest days.

Context and Overview of 2021 Activities

The European Competition Working Group is responsible for all matters concerning European Korfball Competition within IKF (with the exception of 'A' events such as the European Championships). The ECWG is responsible for match schedules, appointment of tournament officials (Coordinating Officer, Jury, and IT), IKF regulations (with support from the IKF Competition Committee), and progress-monitoring of payments and communication to all European countries with respect to the tournaments under our care. The ECWG also helps to train new officials at tournaments e.g. CO, Jury, IT, and clock operators. ECWG members are frequently appointed to tournaments to facilitate these tasks.

ECWG meets once a month using online communication tools (e.g. Skype). The committee also intends to meet at least once a year in person at an ECWG tournament. Due to the ongoing pandemic in 2021 no physical meeting was possible.

Unsurprisingly, 2021 has been a truly quiet year for ACWG with the vast majority of IKF Asia events being cancelled. A brief description of the remaining ACWG activities follows.

The Korfball Association of Thailand had planned to host IKF Asia U19 & U16 Korfball4 Championships 2021, but the new coronavirus outbreak is continuing to grow in Asia and the rest of the world, and some important



Asia korfball members like China and Hong Kong are still forbidden for travelling to Thailand. Therefore, we had to cancel the event.

4.6. DEVELOPMENT AND EDUCATION COMMITTEE

Jorge Alves, Chairperson

General overview

In January 2021, after several continental meetings, it was held the DEC General meeting where all applications made by D&E counties were discussed and final decisions regarding the allocation of DEC Grants 2021 were taken and communicated to the national organisations.

A total of 30 countries were awarded by DEC Grant: Africa (8), Americas (5), Asia (6), Europe (9), Oceania (2). To check the possibility of executing the projects or even to propose the change and adapt it according to the possibilities taking into consideration the local COVID19 restrictions, during all year, intense communication between the chairman of DEC Jorge Alves and all the national organisations and continental responsible who had projects awarded by DEC Grant.

Unfortunately, while the year continued it became clear that the pandemic prevented the organizing of many scheduled projects.

In the last 3 months of the year, when the execution of the projects or their adaptation was not possible. After the agreement with the continental responsible, it was decided that part of the DEC Grant awarded to some African and Asian countries, where normally the development of korfball is very difficult hampered by the lack of equipment, was used to buy and ship korfs and balls.



Of the total 30 countries that were awarded the DEC Grant 2021, only 4 were able to complete all of their proposed projects and receive the full amount awarded. 16 countries received part of the allocated amount, and 10 did not carry out any projects. The total amount spent by the DEC was 19,093€ of the initially 42,000€ allocated.

Korfball's 2027 Olympic Pledge

Aimed to commit the National Organisations with the development of korfball around the world and to keep the Olympic dream alive, a proposal from DEC was made to all IKF members, where the National Organisations pledge to do whatever is in their power and means to help ensure that by 2027 korfball's visibility, recognition, and impact is such that our sport is a serious candidate for inclusion in the program of the Olympic Games and other multisport games.

In 2021 Jorge Alves (Chairman DEC) had an online meeting with 49 National Federations and 48 of them agree with the proposal and sign the Korfball's 2027 Olympic Pledge during the IKF Congress 2021 (21 from Europe, 10 from Asia, 8 from Africa, 7 from America and 2 from Oceania).

The goals established by the National Organizations, especially when the projects have the cooperation of more than one country were one of the items to take into consideration for the approval of DEC Grant budget to be attributed to D & E Countries as part of DEC activity form 2022.

New Members

During the IKF Congress 2021, it was approved the proposal from DEC to recognise the "Asociacíon de Korfball Perú - Korfball Perú Association" as IKF Associate Member.

Start Korfball in New Countries

Contact was made to start korfball activities in new countries.

Several online meetings took place trying to find persons who can start some korfball activities, especially in schools or universities in countries like Vietnam, Laos, Cambodia, Jordan, Brunei, Chile, Uruguay, Paraguay, Bolivia, and Tunisia.

Meetings

On the 10th of January at 11:00 AM CET, it took place the only DEC General meeting, with all members. It was discussed and approved the projects proposed to be awarded by DEC Grant 2021.

Apart from that, a lot of bilateral online meetings and email communication within the committee have taken place.

New Documents

For the sake of transparency and good governance new conditions of applicability to claim DEC Grant awarded were proposed and approved.

NTERNATIONAL

Those conditions (described below), lead to a new "LETTER OF AWARD OF DEC GRANT 2022". Also, a new "Online Form" was created where all candidates can make their proposals for projects to be awarded by DEC Grant 2022. And a new "REPORT OF PROJECT AWARDED WITH DEC GRANT 2022".

Conditions of applicability:

Before Execution of the Project

IKF|DEC must be informed by email to be sent to jorge.alves@ikf.org, office@ikf.org, and the continent responsible (see below), 2 weeks before the start of the project who was awarded.

The DEC grant can be used only for the projects that are approved by the DEC. Changes can be implemented only when requested and approved by DEC in advance.

During Execution of the Project

Evidence like social media links, photos, and videos that can be published in the IKF media must be sent by email to office@ikf.org during the execution of the project.

After Execution of the Project

The official "REPORT OF PROJECT AWARDED WITH DEC GRANT 2022" must be fully completed and submitted by email to: office@ikf.org, jorge.alves@ikf.org, the continental responsible and to erik.buizer@ikf.org within a maximum of 6 weeks after the end of the project.

Official receipts, invoices, or tickets must be submitted. Only costs that were approved (described above Project "details") and are directly connected with the project can be claimed, for instance: flight tickets for instructors, renting a sports hall, accommodation of participants, shipment of equipment, etc.

Evidence of the implementation of the project like social media links, photos, and videos must always be attached to the report besides the ones sent during the execution of the project. (Video and photos are mandatory).

Note: Projects planned for completion after 20 November 2022 require approval of the DEC. For these projects, DEC will establish a deadline for the report to be submitted. Besides this exception, in any case, reports received later than 31 December 2022 will be taken into consideration.

Matters discussed at DEC meetings included

The main activity of the DEC remained the application, awarding, and monitoring of IKF DEC grants to support the worldwide development of korfball. Whoever actions were made to start korfball in other countries and, in countries where there are korfball activities to accomplish the requirements for those to apply for IKF membership.

Future Activities

Execution and monitoring of DEC projects awarded by DEC Grant in 2021 will be an important objective.



4.7. DISCIPLINARY COMMITTEE

Due to the circumstances we all know and had to deal with, 2021 was a quiet year for the DC. There was only one case we had to deal with: a red card on the last day of the IKF EKC-A 2021, to the player Olav van Wijngaarden (NED).

Let's hope that the pandemic will soon be under control and normal competitions on national and international level can take place again.

4.8. ETHICS COMMITTEE

4.9. INFORMATION AND COMMUNICATION TECHNOLOGY COMMITTEE

Anita Derks, Chairperson

The committee and IKF Office were busy during the year with the development and testing of the new TIP (Tournament Import Portal). This portal has been developed to digitalise and professionalise the process of submitting players lists for tournaments. Multiple tests were done with the involvement of team managers of national teams, resulting in the final version used during the IKF U21 Korfball World Cup, the IKF European Korfball Championship B-Division and the IKF European Korfball Championship A-Division. The next step is to write a handbook and train the jury so that the tournament jury chair can use the overall jury software.

4.10. LIVESTREAM AND SOCIAL MEDIA COMMITTEE

Anita Derks, Chairperson

IKF and media

In 2021 only three events were organised. The IKF U21 Korfball World Cup 2021, IKF European Korfball Championship B -Division 2021 and IKF Championship A-Division 2021. All these events were livestreamed, with the results on <u>www.worldkorfball.sport</u>.

Next to this there was a live TV broadcast from the final of the Championship A -Division 2021 in Belgium, the Netherlands and Czech Republic



We are happy that, even though the Covid-19 pandemic broke out, promotion of korfball via social media was successful in connecting korfball-lovers all over the world. The IKF websites korfball.sport and worldkorfball.sport, social media channels like Facebook, Twitter, LinkedIn and the IKF YouTube channel, were used to promote pre-recorded matches and show some local nice events all over the world.

IKF and IWGA/IOC

We continued to co-operate with the IWGA channel of the International World Games Association (IWGA) by offering them our IKF YouTube channel video content for further distribution. We cooperate in the same way with the Olympic Channel. In preparation towards the World Games 2022 in Birmingham (USA), the IWGA created 'A Beginner's Guide to Korfball' in cooperation with us as IKF. This nice-looking video explains the basics of korfball for people that are not familiar with our sport.

IKF Social Media and IKF websites

Several events did not take place due to the Covid pandemic, but from September to December there were three events. It is good to see that this event reached many people. Interestingly, EKC B had much more impact and reach on Facebook than EKC A.

To increase our visibility in Latin America, we set up the social media department IKF Americas. This was realized at the end of 2021.

Manual Hernandez and Camilla Stucchi created various content for these newly installed social media channels. In this way we reached more people and created greater visibility within the continent.

One of our goals was to invest in the Social Media platform ("WeChat"), to increase the impact of the IKF Social Media messages in Asia. We have investigated how we can strengthen social media in Asia and decided not to create a separate social media channel, but to use existing platforms. In addition, one of the members of the IKF committee has become a member of the Asia social media committee

4.11. MARKETING AND COMMUNICATION COMMITTEE

Anita Derks, Chairperson

The committee has been expanded with four new members from different countries and continents. We discussed the previously developed Marketing strategy of Triple Double with these new members. This will require our full attention in 2022 to develop an overall communication and marketing strategy.



IKF and sponsors

A new sponsorship agreement has been concluded between the IKF and Mikasa Corporation. An important part of the agreement is that the MIKASA K5 shall remain the IKF's official ball. This means that the MIKASA K5 will continue to retain its exclusive status at all IKF events and IKF development activities. The extensive positive experiences of athletes worldwide with the MIKASA K5, both at elite and at grassroots levels, played an important role for the IKF in extending the partnership.

IKF and news

The Marketing and Communication Committee supported the IKF office in 2021 to implement the IKF newsletter. Nine editions have been released

Projects for 2022

Because of the pandemic several projects from 2021 are still in progress or will start in 2022;

- We continue to work on the marketing, communications and IT plans as adopted in August 2019 in South Africa.
- We will continue to focus on increasing the world-wide awareness of the sport. Greater awareness is vital for the long-term goals of the IKF. To achieve this, we will post more targeted content on the IKF social media platforms from different countries. We are also developing a strategy to increase the attention of non-korfball fans.
- For the World Games we are making a portfolio for the press 'What is korfball'. In addition, there will be a beginner's guide for korfball.
- We are posting an open call to select a strategic partner via a RFP process for IKF's ambition to create and operate its own global live streaming platform / social media platform.
- We are going to expand the livestream team so that we will become more robust and can achieve livestreams on more continents. The new team members are trained during a tournament.
- We will write a handbook and train the jury so that the tournament jury chair can use the overall jury software. At this way we implement the TIP (Tournament Import Portal).
- The existing FB page of Korfball.org is an official page to share information. The content is formal. Target groups of the existing FB page come here mostly for information and interaction is therefore minimal. Hence, we are preparing a proposal to create a FB group for korfballers (players & fans) to interact with each other. The content will be more relaxed & entertaining (less formal). This is to gather "all korfballers" and create one korfball online community.



- We are working on aligning the goals and working methods so that we realise a successful cooperation. Therefore, structural consultation is planned to distribute tasks and to learn from each other.
- We will continue to be more externally focused. Greater external focus equals increased awareness of korfball outside of the current korfball community. The Marketing and Communication Committee will make a plan to achieve this which will include an updated brand positioning strategy for which we will collaborate with an external brand advisor.
- The pandemic is still among us and it is unclear whether all planned IKF events will go ahead. But if possible, we will continue to livestream all matches of major IKF events via the internet at worldkorfball.org. The goal is to move from the IKF YouTube channel to a platform with sponsorship opportunities. Our goal is to have all data in our own possession by the end of 2022. This will allow IKF to create much more commercial value from the already sizeable number of online viewers as currently IKF has attracted more than 50 million views on its YouTube channel and it is believed that such results can be leveraged a lot more if the data insights of this audience would be available and actionable for IKF.
- We will encourage our continental confederations and our members to produce content, including photo and/or video and share this with the IKF headquarters on a regular basis.
- The Marketing and Communication Committee will support the IKF office in 2022 to further develop and implement the IKF newsletter.
- MarC's efforts to create new partnerships is still a priority. First of all, we will make a strategy. The previous investments with sports marketing agency Triple Double will also be used to create a unified brand positioning strategy that articulates korfball's unique ability for friendship, fun and (gender) equality. This enhanced brand positioning document will be actively promoted to all national federations so the messaging will be conveyed consistently at all levels and in all languages. This is needed to increase the number of sponsorship deals and to support IKF's longer term vision on getting our sport included in the Olympic calendar. It is important to cooperate with the IKF member countries. Together we will endeavour to become successful. We are also starting to build out a list of potential sponsors, sponsor categories and sponsor packages.



4.12. MEDICAL COMMITTEE

Sandra Koers-Chung, Chairperson

The corona crisis has turned our world upside down. In 2020 and 2021 we lived in a new reality full of challenges, including for the sports world. In this strange and worrying times of the COVID-19 pandemic several protocols for the international tournaments were written by the Medical Committee as an advice towards the EXCO of the IKF. The intensity of the pandemic and the rules and protocols for all countries differ and the medical committee tried to review the regulations per tournament as an advice towards the EXCO of the VOLD-19 pandemic several protocols for the volunteers, IKF-members, players and staff.

The Medical Committee will try to work on the visibility of the Committee, for example on the website of the IKF. A new general e-mailadress will be made by the IKF for the Medical Committee to maintain better contact with the medical committees and officials of the affiliated countries.

The Medical Committee worked on information based on literature for the IKF website. The few articles that have been written need to be placed on the website for all the IKF members.

The Rules of Korfball 2020 (update 2021)

Based on remarks and feedback from some national organisations about situations that occur during the competition some small amendments to The Rules of Korfball were prepared to be published in 2022.

Statements to clarify The Rules of Korfball

Based on remarks and feedback from some national organisations about situations that occur during the competition, PRC prepared some statements to clarify some rules who have different interpretations.

A statement was published in July 2021 about "Playing Rules regarding the number of players on the final list of IKF tournament."

Other Statements were prepared to be published in 2022: "PRC Statement regarding Time Out and Substitution" and "PRC Statement regarding one shot allowed after fall/injury or play on".

Referee Signals

Keep working on the process to prepare the new Referee Signals to be published in 2022.

Playing Rules Experiments

6. FINANCIAL REPORT

6.1 General Introduction

It is our pleasure to present you with the IKF's Annual Accounts for the calendar year 2021.

Since in 2021 Covid 19 still limited our society the financial situation is not comparable with the budget or figures of former years.

Except for 3 tournaments all the other events of 2021 had to be cancelled. In-person meetings were not possible and changed into digital meetings. Overall, this means a lot of costs were saved.

The balance sheet as per 31 December 2021, the statement of Income and Expenditure for 2021 and the accompanying explanatory notes, which together form the 2021 Annual Accounts, are included in this report.

The IKF's Annual Accounts are presented in accordance with Dutch legislation regarding annual reporting; more specifically: "Richtlijn 640" for non-profit organizations.

Currency

All sums presented in the Annual Accounts are expressed in Euros.

Financial Position

After a first calculation of the result there appeared to be a surplus of 18,007.97 EUR.

On the balance we still have the debt claim on the South African Korfball Federation concerning the payment of the korfball floor for the World Korfball Championship (16,510.78 EUR). At the end of 2021 it seems unrealistic that we can still collect the claim. Therefore the Executive Committee decided to write off the claim. Of course the claim stays registered for the future if we can still recover it or part of it.

Technically (due to the legal "Richtlijn 640") the Annual Accounts of the IKF then show a positive balance of 1,497.19 EUR. If we take into account the withdrawal of the reserve for the Congress 2021, as budgeted (8,000 EUR), we come in comparison with the budget (0.00 EUR) to a positive result of 9,497.19 EUR.

Proposed allocation of the resulting balance (9,497.19 EUR)

The Executive Committee proposes to install a reserve of 6,500 EUR for Extra Development Activities in Asia/Africa. For Marketing the Executive Committee expects for 2022 a new impulse and wants to reserve a budget of 3,000 EUR. The balance of -2.87 EUR will be deducted from the General Reserve.



Legal "Richtlijn 640" information

The International Korfball Federation with its statutory seat in Utrecht, The Netherlands has as goals according to the Statutes:

Article 6. OBJECTIVES AND PRINCIPLES.

The objectives of the IKF shall be to:

- Encourage, promote, develop and control korfball at all levels throughout the world;
- Support and maintain the ideals and objectives of the Olympic movement and in particular the fight against doping by means of appropriate tests;
- Exercise jurisdiction over and to determine disputes or disagreements between Members, between Continental Confederations, between Members and Continental Confederations, between Athletes or officials and IKF and between Athletes or officials and a Continental Confederation;

Establish and maintain an efficient administration;

- Preserve the independence of the IKF in all matters directly or indirectly concerning korfball without the intervention of any outside authority; and
- Conduct itself and take such administrative, financial or other actions as are necessary and in conformity with and in furtherance of its objectives.
- The IKF, its continental confederations and the National Organisations shall not allow any discrimination on the grounds of race, religion or politics. The organisers of official IKF events shall ensure that a visa be granted to any representative of any national organisation.

Finally

The IKF Council compliments its Financial Administrator for efficiently handling the IKF's finances and would like to express its gratitude for doing so.

6.3 EXPLANATORY NOTES ON THE BALANCE SHEET

3.1. General

Comparative figures as per 31 December 2020 have been placed, for the purpose of comparison, next to the 31 December 2021 balance.

3.2. Accounting principles

Fixed assets:

Fixed assets have been determined on the basis of cost price, less linear deprecation, which is based on the economic life.

Fixed assets of relatively low value have been added to the expenditures and are included without residual value.

Current assets:

Stocks are valued, if necessary, against historical costs, following deduction of the provisions, as and when deemed appropriate.

Claims are included against the nominal value, being deducted if necessary as bad debts. Accrued and liquid assets are capitalized against the nominal value.

Short-term debts and funds:

Short-term debts, including both accruals and deferred income and funds, have been included against the nominal value.

Principles of result determination:

The result is determined according to the difference between the general income and the expenses accrued during the year under review, increased, or reduced, with support, other and unpredicted income and expenditure.

Expenses have been determined on the basis of the accounting principles already referred to.

Other income and expenditures also include interest received and paid.

Principles governing currency conversion:

The Federation's accounts are maintained in EURO.

Funds received in foreign currencies were converted against the day's rate of exchange.


In addition to the liabilities included on the balance, the IKF holds the following rights and obligations as per 31 December 2021:

6.5 EXPLANATORY NOTES ON THE 2021 INCOME AND EXPENDITURES ACCOUNT

1. Committee costs

Due to Covid 19 situation in-person meetings were changed into online zoom/teams meetings. It results in a significant underspending of 12,000 EUR

2. Staff

With 2 fulltime employees and 1 parttime financial administrator we meet the set up budget of 142,000 EUR. Since December 2020 the IKF office moved from Zeist to Utrecht. This results in an extra cost of 3,500 EUR per year.

3. Administration

Due to an increase of our contribution to International Federations we note a small overspending of 1,500 EUR

4. - 15. Competitions

Due to Covid 19 we were only able to organise the European Korfball Championships A (Belgium) and B (Poland) and a low budget U21 World Korfball Championship (Czech Republic). This results in an underspending of costs and profits. The Executive Committee decided to take on the extra costs for corona testing. This results in relatively higher spending on the tournaments in 2021.

In 2021 there was also a purchase of new referee and jury clothing of approximately 10,000 EUR, these costs will be spread over 3 years.

5. Referee Development Program

In 2021 the collaboration with Team TV was further developed.

6. Development and Education - 11. - 20. Development Projects

Together with our partners IOC, Swan Fund, LWIK (the Netherlands), Friends of Korfball (Belgium), and several National Korfball Associations a lot of special development and educational projects are organized to



develop korfball all over the world. As there is a tendency that our partners negotiate directly with the countries we don't receive a total overview anymore of the several projects that are accomplished. Therefore there are no amounts mentioned under numbers 11. and 20.

Despite Covid 19 several countries managed to realize their projects.

The figure under number 6. shows the investment of the IKF in development and education of Korfball. The table below contains amounts paid / received through the IKF Bank Account.

7. Marketing and Communication – 16. Sponsoring – 17. Marketing Income



On the income side we have the sponsoring of IOC and Mikasa (including free balls). The contract with Mikasa (our ball supplier) was renewed in 2018 for 4 years (until the end of 2022).

For Marketing Income we have the revenue Google Ads (Sportaccord) (300 EUR) and the media-rights from the EKC-A (1,850 EUR)

On the expense side of Marketing and Communication we note the photo-coverages and live streams of the 3 tournaments in 2021.

9. - 18. Anti-Doping

Based on the rules of IOC we have to prove that approx,, 9,000 EUR is spend on costs for attending meetings and conferences on anti-doping, on costs for organising educational programs and on costs for anti-doping tests.

For 2021 we can report to the IOC 9,418.45 EUR on in- and out-of-competition tests.

Due to Covid 19 we had no possibility to attend meetings, conferences or organise educational programs.

10. Other Expenses

Main components are:

- Debtors written off: 2,655 EUR
- WKC floor: 16,510.78 EUR
- Other: 625 EUR

13. Subscriptions

This amount is a result of levy decisions made earlier related to country classifications; A, B, C, D, E and F countries approved by the IKF General Meeting in 2019. For 2021 the Executive Committee decided to wave the subscriptions for the E-countries.

14. Rights and Fees

In 2021 we notice again a small revival of new delivered korfs. Due to Covid 19 the referee fee for 2021 was waved.

19. Other income

Main components are:

- Offset of costs regarding to tournaments: 3,806,54 EUR
